The Chairman, Deputy Chairman and the Secretary of ARMECONOMBANK OJSC Board were elected by the Bank's Shareholders Annual Meeting held on 14.06.19.

II. By ARMECONOMBANK OJSC Board's resolution N13/01-14.06.19, it is planned to carry out replenishment of the chartered capital in the amount of AMD 320,320,000 in accordance with authorization granted to the Board by the Article Je of ARMECONOMBANK OJSC Charter.

Pursuant to ARMECONOMBANK OJSC Board's resolution N° 23/02-14.06.19, it is planned to issue 30,800 common shares with AMD 10,400 nominal value and distribute them with AMD 16,250 per share.

The total volume of the shares (calculated at AMD 10,400 nominal value per share) to be allocated makes AMD 320,320,000 (calculated at AMD 16,250 market price per share- AMD 500,500,000), which is completely subject to subscription.

The beginning of the shares placement shall be considered 09:00 o'clock of the 6th working day following the Prospectus registration day by the Central Bank of Armenia, the distributions ends on 31.10.19 at 16:00. In case of full subscription of shares, the Bank will terminate the process of shares distribution.
